1. Product Overview

This chapter provides basic information about the QNAP QVP-xxB surveillance server.

About the QVP-xxB

The QVP-xxB NVR network surveillance server supports real-time video/audio monitoring, high-resolution recording, and playback from multiple IP cameras. With six or eight 3.5-inch SATA drive bays, one HDMI 1.4b port, and two 2.5 GbE host management ports, the QVP-xxB provides great storage space and high-speed networking to meet the requirements of small/medium monitoring environments.

Hardware installation

This section provides information on installing drives, memory modules, and connecting to a computer or network.

Drive installation

The QVP-xxB series is compatible with 3.5-inch hard drives, 2.5-inch solid-state drives, and M.2 solid-state drives.

Installing 3.5-inch hard drives on 3.5-inch trays

- Installing a drive deletes all data on the drive.
- Observe electrostatic discharge (ESD) procedures to avoid damage to components.

- **6.** Attach the case cover.
 - **a.** Place the cover on the device.
 - **b.** Slide the cover forward.
 - **c.** Attach the screws.



- 7. Connect all cables and external attachments.
- **8.** Connect the power cord to the electrical outlet.
- **9.** Power on the device.

Replacing memory modules

The QVP-xxB series has two memory slots. You can increase the memory capacity of the NAS by upgrading memory modules.

Use only QNAP memory modules to maintain system performance and stability. You can purchase QNAP memory modules from authorized resellers.

- c. Verify that the metal connectors are completely inserted into the slot.
- **d.** Carefully press down on the module until the retention clips lock the module into place.



- **7.** Attach the case cover.
 - **a.** Place the cover on the device.
 - **b.** Slide the cover forward.
 - **c.** Attach the screws.



- **8.** Connect all cables and external attachments.
- 9. Power on the device.
- **10.** Verify that the module is recognized by the device.
 - **a.** Log on to QVP as administrator.

- b. Go to Control Panel > System > System Status > Hardware Information .
- c. Check the value for Total memory.



Connecting the device to a computer

Connecting the QVP-xxB to a QNAP NAS allows you to expand storage capacity and back up data to the NAS through Ethernet cable connections on the device. However, you must connect the QVP-xxB to a computer to configure device settings.

- **1.** Power on the device.
- **2.** Connect the device to a computer.
 - **a.** Connect an Ethernet cable to the device
 - **b.** Connect the Ethernet cable to a Gigabit Ethernet port on the computer.



3. Verify that the device is recognized by the computer.

a. Open Qfinder Pro on the host computer.

 - Numbers (0 to 9)
 - Hyphens (-)



The NAS name cannot end with a hyphen.

- **Password**: Specify an administrator password with 1 to 64 characters. The password supports all ASCII characters.
- 7. Click Next.
- **8.** Specify the time zone, date, and time.



QNAP recommends connecting to an NTP server to ensure that the device follows the Coordinated Universal Time (UTC) standard.

- 9. Click Next.
- 10. Select Obtain an IP address automatically (DHCP).
- 11. Click Next.
- **12.** Select the types of devices that you will use to access shared folders on the device.
- 13. Click Next.
- **14.** Configure the disk settings.

- **a.** Select disks for creating a volume.
- **b.** Select a RAID type.
- 15. Click Next.
- **16.** Review the settings.
- **17.** Click **Apply**. A confirmation message appears.

USB One Touch Copy button

The USB One Touch Copy button allows you to copy data backups from a USB device to the QNAP device or from the QNAP device to a USB device.

This feature supports incremental backups. The QNAP device only copies files that were modified or added after the last backup.

To configure the behavior of the button when an external device is connected to the button's USB port, install and use Hybrid Backup Sync on your QNAP operating system. For details, see the Hybrid Backup Sync documentation.

LCD panel

The LCD panel allows you to perform the following operations:

- 6. Wait for 20 seconds or until the device beeps twice.
- 7. Remove the failed drive from the drive tray.
- 8. Insert the new drive into the drive tray.
- **9.** Install the new drive. The device beeps twice.

10. Go to Main Menu > Storage & Snapshots > Storage > Storage/Snapshots .

11. Locate the volume that contains the new drive and then verify that the status is Rebuilding.

Recovering unintentionally removed healthy drives
